The Book Works Education Advocates assisted 260 middle and high school students experiencing educational disruption to reconnect with the school options and academic supports. Of the young people who completed services in 2025, 60.7% reached their education goal.

4b (Code:) (Expenses \$ **286,832** including grants of \$) (Revenue \$)

The Book Works Advocates and AmeriCorps members served 93 students who were not attending school on school days due to suspension, chronic absences, or gaps in school enrollment. 96.5% of the students returned to school following participation.

The Book Works Youth and Family Services team assisted 63 adult caregivers to build skills and access resources to support their children's return to regular school attendance. 100% of participants demonstrated increased skills.
